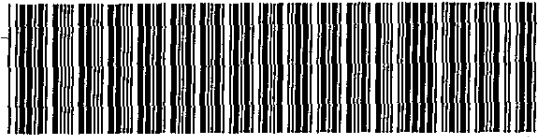

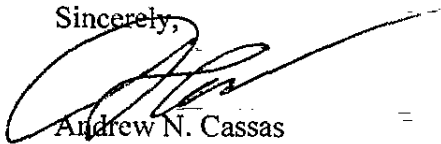

The name of the limited liability company shall be **A&S ACQUISITIONS, LLC**.

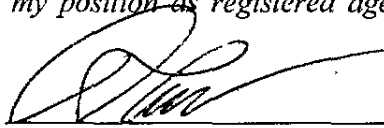
ARTICLE II - ADDRESS

ARTICLE V - EFFECTIVE DATE

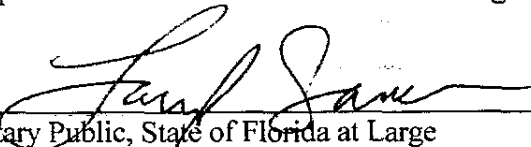
