

ARTICLES OF ORGANIZATION FOR FLORIDA LIMITED LIABILITY COMPANY

Pursuant to Section 608.407 Florida Statutes, the Limited Liability Company named below submits the following Articles of Organization:

ARTICLE I Name

The name of the Limited Liability Company is THOMAS B. DOBIES, L.L.C.

ARTICLE II Address

ARTICLE III Business
