

**ARTICLES OF ORGANIZATION FOR
GOFFRI INVESTMENT TRUST, LLC.
A FLORIDA LIMITED LIABILITY COMPANY**

The undersigned, desiring to form a limited liability company under and pursuant to Florida Statute, Section 608.401 et. seq., entitled the Florida Limited Liability Company Act, does hereby adopt the following Articles of Organization for such company:

1. **NAME.** The name of this company shall be **GOFFRI INVESTMENT TRUST, LLC.**
2. The address of the principal office of the Company is 4875 North Federal Highway, 7th Floor, Fort Lauderdale, Florida 33308.
3. **REGISTERED AGENT AND OFFICE.** The name and street address of the initial registered agent and office for the Company is as follows: **ARTHUR R. ROSENBERG**, located at 4875 North Federal Highway, 7th Floor, Fort Lauderdale, Florida 33308.
4. **MANAGEMENT OF THE COMPANY.** The business of the Company shall be managed by **Avishay Goffri**, the Managing Member of the Company, whose address is 4875 North Federal Highway, 7th Floor, Fort Lauderdale, Florida 33308 or such other managers as may be appointed by the members in accordance with the provisions of the Operating Agreement.
5. **MEMBERS OF THE COMPANY.** The names and addresses of the Members are as set forth in the Operating Agreement.
6. **PURPOSE OF COMPANY.** The Company is being formed to engage in any activity or business permitted under the laws of the United States and of the State of Florida.
7. **REGULATIONS OF COMPANY.** The members may adopt such Operating Agreement or Regulations governing the operations, and management of the Company, the admission of new members, the transfer of a member's interest and the termination of member(s). The members shall have the power to adopt, alter, amend or repeal the regulations of the Company, unless vested in the Manager(s) of the company by these Articles or any amendments made hereto. Regulations adopted by the Members or by the Manager(s) may be repealed or altered, new Regulations may be adopted by the Members, and the Members may prescribe in any Regulations made by them that such Regulations may not be altered, amended or repealed by the Manager(s).


