ARTICLES OF ORGANIZATION FOR GOFFRI INVESTMENT TRUST, LLC. A FLORIDA LIMITED LIABILITY COMPANY

The undersigned, desiring to form a limited liability company under and pursuant to Florida Statute, Section 608.401 et. seq., entitled the Florida Limited Liability Company Act, does hereby adopt the following Articles of Organization for such company:

- NAME. The name of this company shall be GOFFRI INVESTMENT TRUST, LLC.
- The address of the principal office of the Company is 4875 North Federal Highway, 7th Floor, Fort Lauderdale, Florida 33308.

- 4. MANAGEMENT OF THE COMPANY. Regulations adopted by the Members or by the Manager(s) may be repealed or altered, new Regulations may be adopted by the Members, and the Members may prescribe in any Regulations made by them that such Regulations may not be altered, amended or repealed by the Manager(s).
