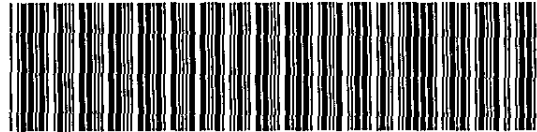

PROPERTY**


