**ARTICLES OF ORGANIZATION
FOR
AZALEA PARK PLAZA, LLC**

ARTICLE 1 – Name. The name of the limited liability company shall be Azalea Park Plaza, LLC.

ARTICLE 2 – Addresses. The mailing address of the limited liability company shall be: c/o Harp Realty, Inc. d/b/a Remax Realty Partners, 4510 Curry Ford Road, Orlando, Florida 32812. The principal office address of the limited liability company shall be: 1 South Semoran Boulevard, Orlando, Florida 32807.

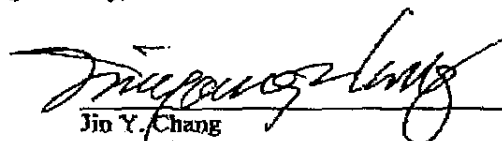
