The name of the limited liability company is: Gray Family Properties, LLC.

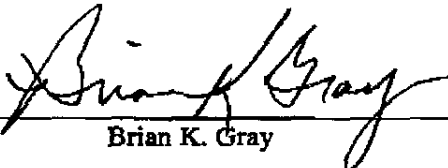
ARTICLE II. ADDRESS

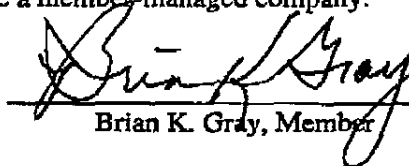
