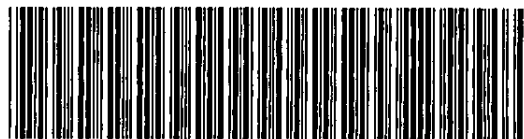

(changing name to GRIECO - COBURN SERVICES, LLC)



1. Article I is hereby is amended to change the name of the Company to:


GRIECO - COBURN SERVICES, LLC


