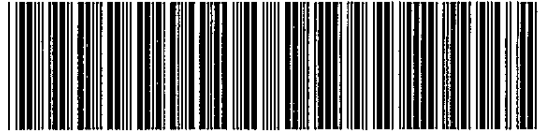

**ARTICLE I - Name:**

The name of the Limited Liability Company is: **Kejica Investments, LLC** (hereinafter the "Company").

**ARTICLE VII - Limitation on Agency Authority of Members:**


