**ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges and files the following Articles of Organization.

**ARTICLE I  
Name**

The name of the Limited Liability Company is JOHN CURTIN HOME INSPECTION, LLC.

**ARTICLE II  
Address**

The mailing and street address of the Company's principal office is 19227 W. Indies Circle, Tequesta Florida 33469

**ARTICLE III  
Purpose and Powers**

The general purpose for which the Company is organized is to provide building inspection services and such other business as may be determined by the member. The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.




