



**ARTICLES OF DISSOLUTION

1. **NAME OF LIMITED LIABILITY COMPANY.** The name of this limited liability company is **FACECHECK LLC** (the "Company"). The Articles of Organization were filed on June 24, 2005 and assigned document number L05000063264.

2. **EFFECTIVE DATE OF DISSOLUTION.** The effective date of the dissolution of the Company is January 1, 2008.

3. **OCCURRENCE THAT RESULTED IN DISSOLUTION.** The dissolution of the Company was authorized by the Unanimous Written Consent of the Members of the Company under F.S. 608.441(1)(c) on January 18, 2008.
