#### ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

#### ARTICLE I - NAME

The name of the limited liability company shall be McGarvey/Tuscany LLC (the "Company").

#### ARTICLE II – ADDRESS

### ARTICLE III - DURATION
