The name of the limited liability company is: B & P Dental Enterprises, LLC.

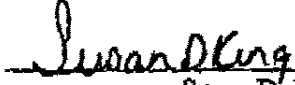
ARTICLE II. ADDRESS

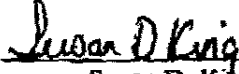
