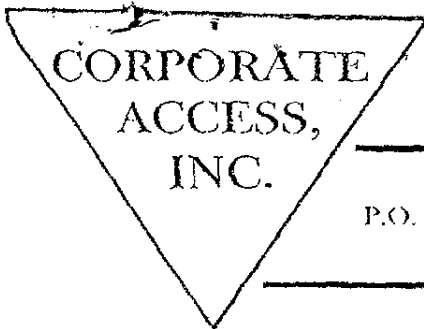

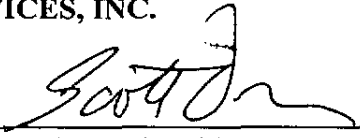
FIRST: The Articles of Organization were filed on June 27, 2005 and assigned document number L05000063326.
