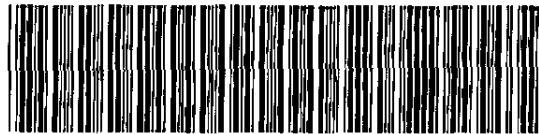




#### **ARTICLE VI - ADMISSION OF ADDITIONAL MEMBERS**
