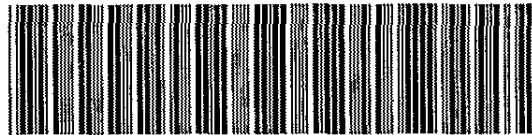

**ASSIGNMENT OF PARTNERSHIP INTEREST**

Upon assignment of the Interest to the Assignee, the Assignor will cease to be a Partner in the Partnership.

2. In return for good and valuable consideration and the sum of TEN 10/100 Dollars (\$10.00), receipt of which is hereby acknowledged, the undersigned Assignor does hereby transfer any and all rights and interest and obligations in the Partnership to the Assignee.
