FOR

**ARTICLE 1 – Name.** The name of the limited liability company shall be Lift Productions, LLC.

**ARTICLE 2 – Addresses.** The mailing address and principal office of the limited liability company shall be 1247 Marina Point, #103, Casselberry, Florida 32707.


