**ARTICLES OF ORGANIZATION

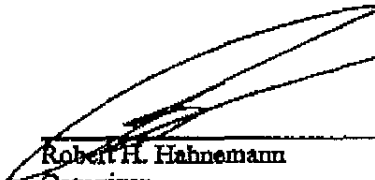
ARTICLE VIII

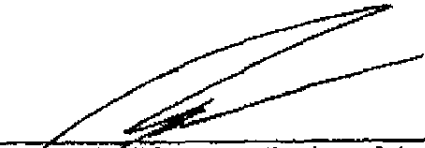
**CERTIFICATE OF DESIGNATION
