Notwithstanding any other provisions of these Articles, The Vizcayans, LLC shall not carry on any activity not permitted to be carried on by: (1) an organization exempt from idearal income tax under section 501(c)(3) of the Code; or (2) an organization contributions to which are deductible under sections 170, 2055, and 2522 of the Code.
