ARTICLES OF ORGANIZATION OF B & D GROUP HOLDINGS LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, pursuant to Chapter 608 of the Florida Statutes, hereby makes, acknowledges and files the following Articles of Organization (the "Articles").

ARTICLE L NAME

The name of the limited liability company is B & D GROUP HOLDINGS, LLC (the "Company").

ARTICLE II. MAILING AND STREET ADDRESS

The mailing address and street address of the principal office of the Company shall be 17760 NW 2nd Avenue, Suite 200, Miami, FL 33169.
