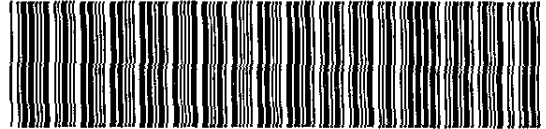

The company is to be managed by its members, and is therefore a member-managed company. The initial managing member is EUGENE J. PAKUS, at the principal office stated above.


ARTICLE VI: REGISTERED AGENT

The effective date of the company shall be June 27, 2005.


