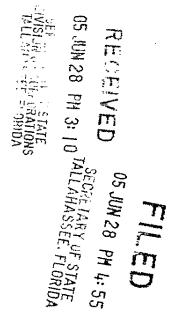

# **ARTICLES OF ORGANIZATION** ROY SOUTHWEST FLORIDA INVESTMENTS, LLC

# **ARTICLE I. NAME**
