

The undersigned, for the purposes of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

**ARTICLE I**

**NAME**

The name of the limited liability company shall be:  
PARAMOUNT/PARTNERS INSURANCE SERVICES, LLC

**ARTICLE II**

**ADDRESS**

The mailing address and street address of the principal office of the company shall be: 5808 Old Pasco Road, Wesley Chapel, Florida 33544.

The company shall begin its existence on the date that these articles of organization are filed by the Florida Department of State. The company's existence shall be perpetual unless the company is earlier dissolved as provided in these articles of organization.

## ARTICLE VI

### ADDITIONAL CAPITAL CONTRIBUTIONS

Each member shall make additional capital contributions to the company only on the unanimous consent of all the members.

## ARTICLE VII

### ADMISSION OF NEW MEMBERS

No additional members shall be admitted to the company except with the unanimous written consent of all the members of the company and on such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the company according to regulations as may be adopted by the members of the company, but the transferee shall have no right to participate in the management of the business affairs of the company or become a member unless all the other members of the company other than the member proposing to dispose of his or her interest shall first approve of the proposed transfer by unanimous written consent.

## ARTICLE VIII

### TERMINATION OF EXISTENCE

On the death, bankruptcy or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the company, the business of the company shall be continued by the consent of all the remaining members.

## ARTICLE IX

### MANAGEMENT

The company shall be managed by a manager in accordance with regulations adopted by the members for the management of the business affairs of the company. These regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization. 

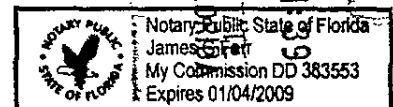


