

ARTICLES OF ORGANIZATION OF

ANM at Canyon, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be ANM at Canyon, LLC (the "Company").

The Operating Agreement and/or Regulations, if any, or otherwise the minutes of the Company, shall determine the manner in visiton such Manager(s) are elected and appointed, and may contain any provisions for the regulation and management of the affairs of the Company that are not inconsistent with the law or these Articles of Organization.
