ARTICLES OF ORGANIZATION

KING CRAB INVESTMENTS, LLC

ARTICLE I - Name: The name of the Limited Liability Company shall be KING CRAB INVESTMENTS, LLC.

ARTICLE II - Address: The mailing address and street address of the principal office of the Limited Liability Company is:

ARTICLE IV - Management: The Limited Liability Company will be a manager-managed company and the name and address of the

The Manager on his own shall have full authority to open bank accounts for the Company and deposit, disburse, write checks, and otherwise act with regard to the Company's bank accounts.

ARTICLE V - Ownership and Members:

ARTICLE VII - Members Rights to Continue

Business: The remaining members of the limited liability company will have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the limited liability company, subject to such provisions governing such event as may be set forth in any applicable Operating Agreement.

ARTICLE VIII- Applicable Regulations: If the Company does not have an Operating Agreement, as may be allowed under Florida Statutes, then the provisions of Chapter 608, Florida Statutes, or successor statutory provisions, will serve to govern

the operations of the Company.
