# ARTICLES OF ORGANIZATION OF GILMAR MACCAGNAN INTERNATIONAL ARTISTIC PORTRAITS SECCIMENCE STATE TALLAHASSEE, FLORIDA

The undersigned hereby certifies that she is executing these articles of organization for the purpose of forming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit.
