**ARTICLES OF ORGANIZATION FOR  
FLORIDA LIMITED LIABILITY COMPANY**

The undersigned authorized representative, desiring to form a limited liability company pursuant to the provisions of the Florida Limited Liability Company Act, hereby submits, and files with the Florida Department of State, these Articles of Organization.

**ARTICLE I - Name**

The name of the limited liability company created hereby ("the Company") is: **DIGITAL VIDEO SERVICE, LLC**

**ARTICLE II - Purpose**

The total number of membership units authorized to be issued by the Company shall be 10,000 units. The initial members of the Company and their ownership interest therein shall be set forth in the Operating Agreement of the Company.


**ARTICLE VIII - Admission of Additional Members**
