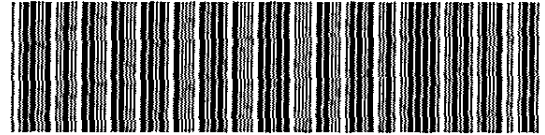

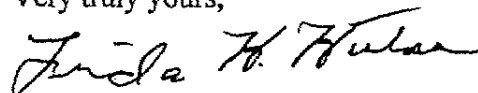

ARTICLE I. NAME

The name of the Limited Liability Company ("Company") is TRADEMARK PROPERTIES, L.L.C.
