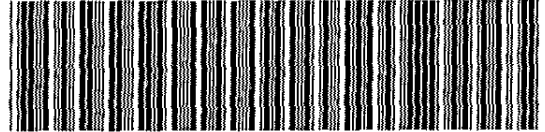

This limited liability company is referred to in these articles as "the Company."


ARTICLE II - PRINCIPAL OFFICE ADDRESS


