





## THE RIVER VIEW OF FANNING SPRINGS - 40, LLC

# a Florida limited liability company

- 1. The name of this limited liability company is The River View of Fanning Springs 40, LLC (the "Company").

This Company shall have all of the powers enumerated in the Florida Limited Liability Company Act, as amended from time to time.



The foregoing right of indemnification shall not be exclusive of any other rights to which any officer, employee or agent may be entitled as a matter of law or which such person may be lawfully granted.
