THESE ARTICLES OF DISSOLUTION (these "Articles") of COMMENCIAL TRAINING SOLUTIONS, LLC, a Florida limited liability company (the "Company"), are submitted effective as of the 2 day of Dezero, 2013, in accordance with §608.445 of the Florida Limited Liability Company Act (the "LLC Act").

The name of the Company dissolved pursuant to these Articles is:

"COMMERCIAL TRAINING SOLUTIONS, LLC"

The effective date of the dissolution contemplated by these Articles is the date of filing hereof.

The occurrence that resulted in the Company's dissolution pursuant to §608.441 of the LLC Act was the occurrence specified in §608.441(1)(c) of the LLC Act - the written consent of all of the members of the Company to dissolve the Company and wind up its affairs.

All debts, obligations, and liabilities of the Company have been paid or discharged pursuant to §608.4421 of the LLC Act, or adequate provision has been or will be made therefore pursuant to §608.4421 of the LLC Act.

In settling accounts after dissolution of the Company, the assets of the Company shall be distributed in the order contemplated by \$608.444 of the LLC Act.

There are no suits pending against the Company in any court.
