ARTICLES OF INCORPORATION OF Platinum Force Investigations And Security Agency Limited Liability Company

KNOW ALL MEN BY THESE PRESENTS: That We, <u>Timothy C. Mingo</u> and <u>Michael C. Sutton</u>, desiring to form a limited liability company for the purposes set forth herein and in conformance with the Florida Limited Liability Company Act, do establish:

- 1. <u>Company Name</u>. That the name of the limited liability company is <u>Platinum</u> Force Investigations And Security Agency Limited Liability Company.

- 7. Additional Liability of Members. That no additional capital contributions will be required.
- 8. <u>Admission of Additional Members</u>. That additional Members will be admitted or expelled only with the unanimous consent of all Members entitled to participate in management and upon such terms as are unanimously agreed to by all Members entitled to a dividend upon dissolution or liquidation.
