I hereby file these Articles of Organization as the authorized representative of the member(s) of the limited liability company to be formed pursuant to these Articles of Organization and the laws of the State of Florida.

ARTICLE I

NAME

The name of the limited liability company to be formed hereunder is "OCH Finance LLC" (the "Company").

ARTICLE II

New members may be admitted to the Company with the consent of all members as provided in the Operating Agreement.



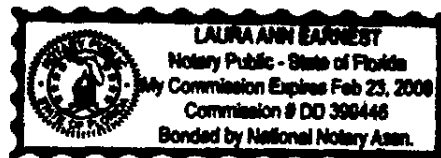


