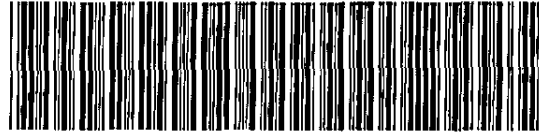

ARTICLES OF ORGANIZATION OF

ARTICLE I – Name:


ARTICLE V – Admission of Additional Members:


