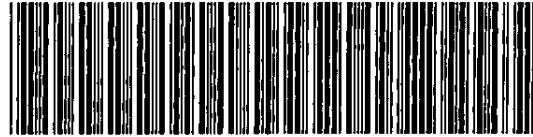



Adequate provisions have been made for the debts, obligations and liabilities, if any, pursuant to F.S. 608.4421.


SIXTH
