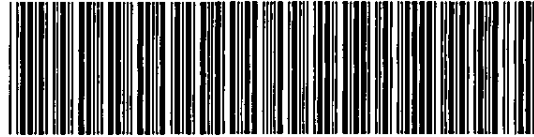



- (a) Article IV of the Articles of Organization is hereby amended to read as follows:




The Company shall be Manager-Managed. The Managers of the Company shall be Richard A. Cartagena and Clifford J. Davis
