



**ARTICLES OF AMENDMENT OF  
ARTICLES OF ORGANIZATION  
OF  
AURIGA EDUCATIONAL MANAGEMENT, LLC**

The undersigned members, acting pursuant to §608.4231, Florida Statutes, as amended, hereby adopts the following Articles of Amendment of Articles of Organization (these "**Articles of Amendment**").

1. **COMPANY NAME.** The current name of the Company is and has been "**Auriga Educational Management, LLC**" since August 5, 2005, when it was changed to "**Auriga Educational Management, LLC**" from "**Auriga Capital Management, LLC**".
2. **DATE OF FILING OF THE ARTICLES OF ORGANIZATION.** The articles of organization were filed on July 5, 2005.
3. **AMENDMENTS ADOPTED.** This Amendment provides for the Company's change of name back to its original name. The text of the amendment is as stated below.

Article I of the Articles of Organization, entitled "Name", is hereby deleted in its entirety and the following Article I shall be substituted in for Article I:

**ARTICLE I**  
**Name**

The name of this Company shall be "**Auriga Sports Management, LLC**".

4 **AUTHORIZATION OF AMENDMENTS.** These Amendments were adopted January 1, 2006, by the members of the Company by a written consent in lieu of special meeting pursuant to Section 608.4231 of the Florida Limited Liability Company Act. The number of votes cast for the amendment by the members was sufficient for approval.

5. **EFFECTIVE DATE.** The effective time and date of this Amendment shall be January 1, 2006.
