

**ARTICLE I - NAME**

**THE NAME OF THIS** Limited Liability Company shall be **JABEZ EXECUTIVE PROPERTIES, L.L.C.**

**ARTICLE II - ADDRESS**

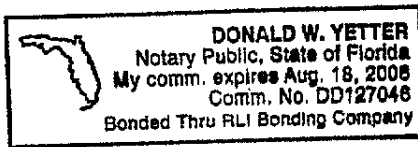
