In accordance with the provisions of Chapter 608, Florida Statutes, as amended from time to time (the "Act"), the undersigned member files the following Articles of Organization for the purpose of organizing a limited liability company.

- 1. Name. The name of the limited liability company is Viking Protective Group, LLC.
