## **ARTICLES OF ORGANIZATION**

THE UNDERSIGNED, DEAN A. SIGLER, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

### **ARTICLE I – NAME**

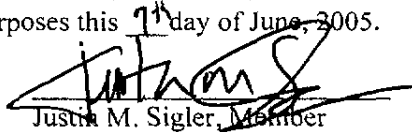
## ARTICLE VII – TERMINATION OF EXISTENCE
