**ARTICLES OF ORGANIZATION
OF
SOUTHERN FIDELITY MORTGAGE GROUP, LLC**

**ARTICLE I
NAME**

The name of the limited liability company is Southern Fidelity Mortgage Group, LLC. The mailing and street address of the principal office of Southern Fidelity Mortgage Group, LLC, shall be at 2755 Millstone Plantation Road, Tallahassee, FL, 32312.

**ARTICLE II
PERPETUALNESS**

The period of its duration is perpetual.

**ARTICLE III
PURPOSE**

The purpose for which the limited liability company is organized is any lawful purpose including but not limited to owning, operating and managing other lawful businesses, and to engage in all activities necessary, customary, convenient, or incident to the foregoing.

**ARTICLE IV
REGISTERED AGENT AND OFFICE**

The location and mailing address of the initial registered office of the limited liability company is Robert H. Kirby, and the name of its initial registered agent at such address is 2755 Millstone Plantation Road, Tallahassee, FL, 32312. The undersigned initial registered agent hereby accepts the appointment as registered agent for Southern Fidelity Mortgage Group, LLC. Further, the undersigned initial registered agent acknowledges that he is familiar with, and accepts, the obligations of being the registered agent as provided under Florida law and specifically under the Florida Limited Liability Company Act.

ARTICLE V
ADMISSION OF ADDITIONAL MEMBERS

The sole initial member of the limited liability company shall be Robert H. Kirby. The Members of the limited liability company shall have the right to admit additional Members upon the approval of those Members holding at least a majority of the Membership Units of the limited liability company, subject to any additional requirements contained in the operating agreement of the limited liability company which may be in effect from time to time.

ARTICLE VI
CONTINUITY OF BUSINESS

Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Company, the business of the Company shall be continued and the Company shall not be dissolved without the prior written consent of all the remaining Members of the Company, except as may be expressly required by non-waivable provisions of applicable law.

ARTICLE VII
MANAGERS

Management of the limited liability company shall be vested in the Management Committee, consisting of one or more Managers, as more fully set forth in the operating agreement of the limited liability company as the same may be in effect from time to time.

The Management Committee shall initially consist of one (1) Manager. The name and address of the initial Manager is as follows:


ARTICLE IX
