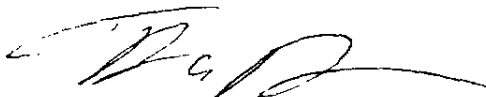

ARTICLES OF ORGANIZATION

OF

SEAN LEWIS CONSULTING, LLC a Florida Limited Liability Company

In compliance with the requirements of F.S. Chapter 608, the undersigned, being a natural person, does hereby act as incorporator in adopting and filing the following Articles of Organization for the purpose of organizing a limited liability company.

ARTICLE 1

Name

The name of the Limited Liability Company ("Company") is Sean Lewis Consulting, LLC.

ARTICLE 2

Duration

The existence of the Company shall begin immediately effective upon the acceptance of these Articles of Organization by the Florida Secretary of State and shall be perpetual.

ARTICLE 3

ARTICLE 4

Registered Agent and Office

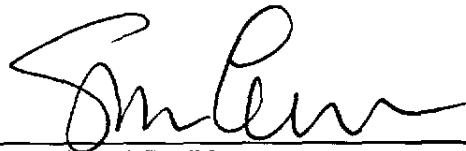
