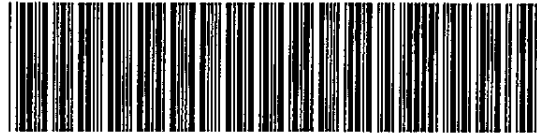



OF

ARTICLE IV


MANAGEMENT
