**ARTICLES OF ORGANIZATION
OF

The undersigned, being a natural person of at least 18 years of age and acting as the Organizer of the Limited Liability Company hereby being formed under Chapter 608 of the Florida Statutes, does hereby adopt the following Articles of Organization for the Limited Liability Company:

FIRST: The name of the Limited Liability Company is:

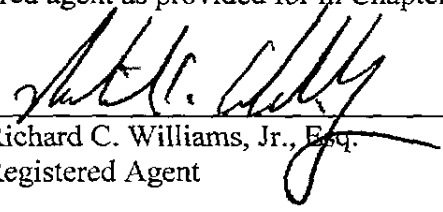
ATARA, L.L.C.

EIGHTH: Additional capital contributions may be made at such times and in such amounts as provided in the Operating Agreement.

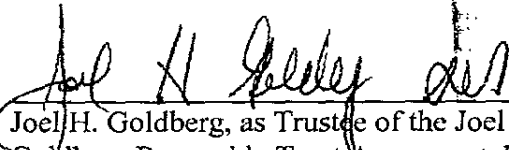
NINTH: The membership interests of the Members are evidenced by Certificates of Membership.

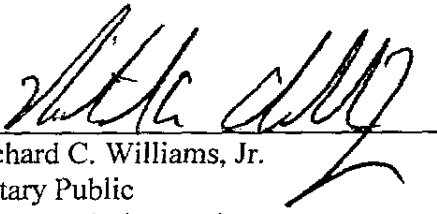
