ARTICLES OF AMENDMENT to ARTICLES OF ORGANIZATION of FRP TECHNOLOGIES, LLC

Pursuant to the provisions of Section 608.411, Florida Statutes, this Florida limited liability company adopts the following Articles of Amendment to its Articles of Organization:

The name of the limited liability company is FRP Technologies, LLC (the "LLC").

2. The effective date of filing of the Articles of Organization of the LLC was July 6, 2006 (the "Articles").

3. The holders of a majority of the membership interests deem it to be in the best interest of the LLC to amend Article V of the Articles.

4. Article V of the Articles of Organization of FRP Technologies, LLC, a Florida limited liability company, is hereby amended in its entirety to read as follows:

ARTICLE V

Admission and Withdrawal of Members; Membership Interests

No additional members shall be admitted to the Company except with the written consent of the olders of a majority of the membership interests of the Company. Membership interests of members admitted to the Company shall have pro rata rights to allocations of profits and losses, pro rata rights to receive member distributions and pro rata rights to vote in accordance with their percentage ownership interests in the Company, provided that with the written consent of the holders of a majority of the membership interests of the Company, the Company may issue preferred membership interests in the Company. The preferred membership interests have all the same rights to allocations of profits and losses, rights to receive member distributions and rights to vote as other membership interests, except that the members holding such preferred membership interests shall be entitled to receive all member distributions by the Company until such members have received distributions from the Company equal to such members' capital contributions to the Company.

5. The foregoing amendment shall become effective as of the date these Articles of Amendment are filed with the Secretary of State of Florida.
