**ARTICLES OF ORGANIZATION
OF
STEEL CURTAIN OF CENTRAL FLORIDA, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I

Name. The name of the limited liability company shall be STEEL CURTAIN OF CENTRAL FLORIDA, LLC ("Company").

ARTICLE II

Address. The mailing address and street address of the principal office of the Company shall be 2615 Alaqua Drive, Longwood, Florida 32779.

ARTICLE III

Duration. The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in the operating agreement of the Company.

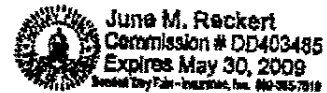
