ARTICLES OF ORGANIZATION OF

A FLORIDA LIMITED LIABILITY COMPANY

The undersigned desiring to form a Limited Liability Company under and pursuant to Section 608.404 of the Limited Liability Act, pursuant to Chapter 608 of the Plorida Statutes, of the State of Plorida, do hereby certify as follows:

FIRST: The name of said Limited Liability Company shall be MP HOLDINGS, LLC, and the mailing address and the street address of the principal office of the limited liability company shall be: 3124 S.W. Wimbledon Terrace, Palm City, Florida 34990.

SECOND: MP HOLDINGS, LLC, shall have a perpetual duration from the date of filing of these Articles of Organization.
