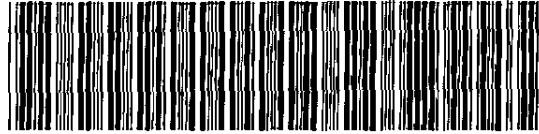

ARTICLE I - Name

The name of the limited liability company is ZION TREE, LLC (the "Company").
