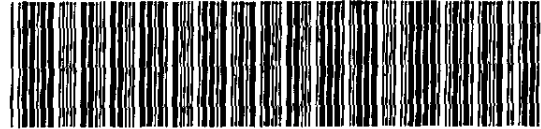

document number L05000067623.


**SECOND:** The following amendment(s) to the Articles of Organization was/were adopted by the limited
