FIRST: The Articles of Organization were filed on July 11, 2005 and assigned document number L05000067791.

SECOND: The following amendment(s) to the Articles of Organization was/were adopted by the limited liability company:

The name is to be changed to CAROL A. GOLLY, P.L.

Article VI - Purpose: The purpose of the limited liability company and the nature of its business is as follows:

1. To engage in every aspect of the practice of licensed clinical social work as a professional limited liability company and to provide services incident thereto.
